GRANTVILLE AREA FOOD PANTRY

The Grantville Area Food Pantry, located at Faith United Church of Christ (on Route 743, just north of Route 22) is a mission project of Faith and of the Grantville Ministerium. The other participants are New Life Assembly of God, Shell's Lutheran Church, St. John's United Methodist Church and Zion Lutheran Church.

Each church sends volunteers one week a month for unloading and shelving of supplies on Wednesday mornings. They distribute food from the Pantry on Thursday evenings from 6:00 to 8:00 p.m. and on Friday mornings from 10:00 a.m. to 12:00 p.m.

The Pantry relies on donations from sponsoring churches of the Grantville Ministerium to pay for the food and other items which are "purchased" from the Central Pennsylvania Food Bank, and receives and welcomes food donated by various organizations, institutions, businesses and individuals in the community. The Pantry also provides a clothing service where donated clothing is sorted and hung for free shopping by clients. Other missions include summer games at Penn National, free tax preparation for low income individuals, new free books for children, emergency gas, heating fuel, lodging and referral information.

BOARD OF SUPERVISORS

Taxes are based on assessed value. Real estate assessments are noted on the right-hand corner of each bill. To determine your real estate tax bill, multiply the assessment times the millage rate (ML) times .001 (a mill is one-tenth of a percent). It can also be determined by multiplying the assessment times the millage rate and then moving the decimal point three places to the left.

The first total amount is a discounted amount. Two percent (2%) of the total bill is subtracted as discount for early payment. Early payment enables the taxing body to earn interest on the deposit and saves the property owner money as well. The second amount is the base fee. The third amount is the base fee plus five percent (5%) penalty for late payment and the fourth amount is the base fee plus ten percent (10%) for later payment.

Personal taxes are based on assessments and equal fees. Individuals are assessed at two hundred and fifty dollars (\$250) and pay one hundred percent of that assessment as a School Occupational Tax. The other amounts are each a five dollar (\$5.00) equal fee.

The first total amount is a two percent (2%) discounted amount for early payment. The second amount is the base fee. The third amount is the base fee plus ten percent (10%) penalty for late payment.

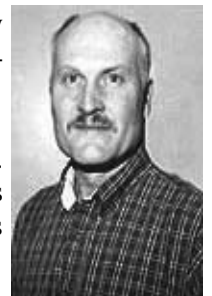

Local governments exist for the purpose of providing services and public facilities to the people who live within their jurisdictions. What they must do and what they may do is specified in the codes and laws enacted by the Commonwealth of Pennsylvania. East Hanover Township is a second class Township and is governed by the Second Class Township Code which was enacted and amended in 1995. Since January 2, 2001, the Board of Supervisors has consisted of five people. The expansion of the Board from three to five members was approved in the 1999 municipal election.

All Supervisors now have a six year term of office. The Supervisors have created the positions of Manager, Secretary-Treasurer, Administrative Assistant, Public Works Director and Road Crew, Building and Park Maintenance, Codes and Zoning Officer, Sewage Enforcement Officer, Wastewater Treatment Plant Operator, Municipal Engineer and Solicitor. They have also appointed a Zoning Hearing Board, Planning Commission, Park and Recreation Board, Environmental Advisory Council and Emergency Management Coordinator. The Environmental Advisory Council is currently on an inactive status due to lack of volunteers to be appointed as members. Board of Supervisor meetings are held on the first and third Tuesday evenings of each month (except holidays and elections) in the Municipal Building beginning at 7:00 p.m. The public is encouraged to attend.

Keith Espenshade, Township Supervisor since January 2004, is a life-long resident of East Hanover Township.

He is a graduate of Dauphin County Technical School. Keith previously served on the Board of Supervisors from 1986 to 1992. He is employed by Espenshade's Plumbing and Heating.



- Enrollees are eligible to apply to participate in the Agricultural Preservation Program at the County level. This program compensates farmers who give up development rights and keep their land available for farming.

AGRICULTURAL SECURITY COMMITTEE (ASC)

This committee oversees any administration required to maintain the Agricultural Security Area in the Township. Specifically, the committee must conduct a review every seven years to update the enrollment area to determine if landowners wish to continue their participation. Enrollment may occur at any time.

The Agricultural Security Committee is currently on an inactive status due to lack of volunteers to be appointed to the Committee.

ELECTION INFORMATION FOR 2011

PRIMARY ELECTION: TUESDAY, TUESDAY, MAY 17
GENERAL ELECTION: TUESDAY, NOVEMBER 8

The purpose of a primary election is to nominate candidates who will be on the ballot in the general or municipal election. When the primary election features a presidential race, the primary election is held on the fourth Tuesday in April.

Pennsylvania has a closed primary, meaning that voters declare their party affiliation and vote only for candidates of that party. Voters not registered for a party may vote on ballot questions, for government study commission candidates, or in special elections if they are on a primary ballot.

Ballot questions may include proposed constitutional amendments or other measures to be decided by popular vote. Special elections are sometimes held when a vacancy occurs in a local, state or federal office.

General elections are held in even-numbered years and municipal elections are held in odd-numbered years. All registered voters may participate.



John Nelligan, Township Supervisor, previously appointed by the Board of Supervisors on February 3, 2009 to fill a vacancy after a voluntary resignation, was elected in 2009 to a 4 year term. John has lived in the Township for over 45 years. He and his wife Carol have two children and four grandchildren.

He is a retired Manager from AMP, Inc., after 36 years of service. His past experience of activities with the Township include serving as a Supervisor, Planning Commission Member, Zoning Hearing Board Member, 209 Traffic Committee, Chief Engineer and Chief of the GVFC. He is currently serving as the Township Emergency Management Coordinator, President of Autumn Leaves, and Facilitator of the East Hanover Public Safety Advisory Council.

PARK AND RECREATION BOARD

In 1980, the Board of Supervisors established the Park and Recreation Board and appointed seven residents to serve 5 year terms. The Board develops, plans and administers a variety of recreational activities such as classes and special events. In 2008, the Board of Supervisors hired Janet Espenshade as the Park and Recreation Director.

The Park and Recreation Board meets on the first Monday of most months (except when changed due to holidays, etc.) at 7:00 p.m., at the Township Building. All meetings are open to the public.

ZONING HEARING BOARD

Each municipality that has enacted a zoning ordinance is required by the Municipalities Planning Code to establish a Zoning Hearing Board (ZHB). Three residents are appointed to the ZHB by the Supervisors for three year terms. One additional resident is appointed by the Supervisors to serve as an alternate. The two main functions of the board are to hear requests for variances and special exceptions. A variance is permission granted by the ZHB for a waiver or modification of some regulation which, if strictly adhered to, would result in unnecessary hardship to the applicant. Unique physical circumstances that do not allow the property to be developed in conformity with the provisions of the Zoning Ordinance must be present. It must also be determined that the applicant did not create the situation and that the variance, if granted, would not alter the character of the surrounding properties or be detrimental to public welfare. In the granting of any variance, the ZHB may attach reasonable conditions as it deems necessary to implement the intent of the act. A special exception allows a certain use in a particular zoning district. As in the granting of any variance, the ZHB may attach to the granting of a special exception, reasonable conditions as it deems necessary to implement the intent of the act.

PLANNING COMMISSION

All subdivision and land development plans must be submitted to the Planning Commission for review and recommendation prior to review and action by the Board of Supervisors. The primary purpose of the review is to ascertain that all requirements of the zoning and subdivision/land development ordinances have been met. The Planning Commission considers the reviews and recommendations of the Township Consulting Engineer, Township Consulting Zoning Officer, Tri-County Planning Commission and Dauphin County Conservation District. The Commission will also determine that the subdivision or land development plan is in conformance with the goals and objectives stated in the Comprehensive Plan. After review, the Commission will recommend an action to the Board of Supervisors. All plans need approval from the Supervisors prior to being recorded at the Dauphin County Courthouse. Five residents are appointed to the Planning Commission by the Supervisors for four year

For those persons living in dwelling units which are excluded from participation in the Township's curbside recycling program, in addition to the above items, aluminum/bi-metal cans, glass, newspaper and plastics #1 and #2 can be recycled at the drop-off depots.

Containers should be rinsed. Plastic caps or metal rings should be removed. Scrap metal, coat hangers, pie plates, aluminum foil, metal cookware, utensils, broken glass, light bulbs, etc. are not acceptable items.

ELECTRONICS RECYCLING

Effective April 17, 2009, Dauphin County officially opened a Recycling Center. The regular hours of operation are Monday, Tuesday, Thursday and Friday from 8:30 a.m. to 4:30 p.m. Wednesday hours are 8:30 a.m. to 8:30 p.m. and Saturdays from 9:00 a.m. to 2:00 p.m. A listing of acceptable recyclable items and fee schedule can be found on their website at www.dauphincounty.org. TIRE DISPOSAL

In the Fall of 2001, Glenn Moyer of Glenn's Auto Service agreed to collect used tires from Township residents. If you have tires to get rid of, please call 469-0167 to make arrangements for drop-off and payment.

AGRICULTURAL SECURITY AREA (ASA)

On May 7, 1991, East Hanover Township created an Agriculture Security Area in response to petition by farms and other large parcel (10 acres or more) landowners in the Township. At present more than 2000 acres of land have been enrolled. Enrollment places no restrictions on the land but does offer the following benefits:

1. It is harder to condemn land that is in an Agricultural Security Area for public purposes.
2. Owners are more protected against nuisance complaints from neighbors relating to farm practices, and

DAUPHIN COUNTY HOUSEHOLD HAZARDOUS WASTE CURBSIDE COLLECTION PROGRAM

The Dauphin County Department of Solid Waste Management & Recycling, with funding help from the Pennsylvania Department of Environmental Protection, provides a free, once-a-year hazardous waste collection of each Dauphin County household. Under this program, Dauphin County residents can properly dispose of the following items: anti-freeze, batteries, brake fluid, chemical strippers, chlorine bleach, contact cement, drain cleaners, fire extinguishers, flea collars and sprays, herbicides, insect repellent, insecticides, kerosene, lawn chemicals, lighter fluid, lye, mothballs, nail polish remover, old propane tanks, oven cleaners, paints, pesticides, pool chemicals, solvents, spot removers, stains and finishes, toilet cleaners and used motor oil. Curbside, Inc. contracts with Dauphin County to provide a curbside collection service for these materials. All collections are by appointment only. Call 1-800-449-7587 for scheduling information and other details.

DAUPHIN COUNTY RECYCLING DROP-OFF DEPOTS

The Recycling Drop-Off Depots, which are being located throughout the county, are designed to serve residents who do not have curbside recycling available. **These Depots also collect additional materials that may not be collected in all mandated curbside programs.** The Dauphin County Board of Commissioners encourages residents to utilize the depots as often as necessary. There is no limit on how much material you can recycle or how often you can recycle.

Corrugated cardboard must be flattened and stacked together. Not permitted are freezer cartons, wax-coated boxes or boxes containing food scraps. Advertising inserts, junk mail, magazines and telephone books must be loose or tied, not placed in paper or plastic bags.

PUBLIC SAFETY COUNCIL

Resolution 2003-02 was adopted by the Board of Supervisors in 2003. The Resolution calls for the formation of a Public Safety Advisory Council. The Council is comprised of emergency providers (representatives of the State Police, South Central EMS, and the Grantville Volunteer Fire Company), a Board representative and members of the community appointed by the Board. This is an advisory council which will provide insight regarding the safety needs of the Township. THE STATE POLICE

The State Police provides primary police service to the municipalities in Pennsylvania which have no local police force. The Harrisburg station, located at 800 Bretz Drive, Harrisburg, PA 17112, serves the Townships of East Hanover, West Hanover, South Hanover, Londonderry, Conewago and Middle Paxton. BULK ITEM COLLECTION (BIC):

Any establishment which participates in the Regular Collection Service will be eligible to use this program with no additional charge. ONE bulk item will be collected each week. Bulk items guidelines:

Containers will be provided by the Township. They will have a capacity of 20 gallons. The first container is provided by the Township free of charge. All recyclables can be placed in one container.

Additional containers are available at the Municipal Building during business hours for a charge of \$10.00 per container and \$3.00 per lid. Recycling containers placed for collection shall not weigh more than fifty (50) pounds.

Collection will occur once a week on the same day at approximately the same time as collection of MSW.

On-Lot Disposal System Management Program (OLDS)

On November 4, 1998, The Board of Supervisors adopted Ordinance 98-6 which established an On-Lot Disposal System. The Township has been divided into three separate OLDS districts. Each district is as follows:

District #1: Bounded on the north by I-81, on the east by the county line, on the south by the township line, and on the west by Sand Beach Road and Shell’s Church Road.

District #2: Bounded on the north by the township line, on the east by the county line, on the south by I-81 and on the west by the township line.

District #3: Bounded on the north by I-81, on the east by Sand Beach Road and Shell’s Church Road, on the south by the township line and on the west by the township line.

Properties in District #1 with an on-lot sewage disposal system must have their septic tank pumped by a hauler/pumper licensed in East Hanover Township on or before November 2, 2011 unless an exemption was applied for and approved.

You do not have to participate in the program; however, no waste haulers will be permitted to collect trash and recyclables in the Township unless there is an exclusion from participation. Non-residential buildings and multi-family dwellings over four units are excluded from participation.

Participants will have two service programs from which to choose.

1. The regular collection service will allow a maximum of four 36 gallon trash bags or cans, one bulk item and unlimited curbside recycling per week. The fee will be \$50.78 per quarter which amounts to an annual fee of \$203.12. Billing will be done on a quarterly basis (January, April, July, October). Additional containers of MSW will require Penn Waste bags. Bags are available at the Municipal Building at the cost of \$3.50 per bag.
2. The optional per container service allows customers who generate a small amount of MSW to purchase bags from the waste hauler. Bags for this service are \$3.50 each and are available at the Municipal Building.
3. Extra Bulk Item is \$25.00/bulk item.
4. Christmas trees can be put out for trash as 1 bag of the 4 bag limit.

Change of Service: May be done at the end of a quarterly billing cycle.

Suspended Services: In order to have service suspended, a 2 week notification period is necessary. Service may be suspended for not less than 30 days.

Collection of recyclables is included in both services. No construction debris will be collected

Customers will provide their own containers of not more than 32 gallons. Containers must not exceed 50 pounds.

All collections will be made between the hours of 5:00 am and 5:00 pm. In the event of a missed service call, collection will be made within 24 hours of notification.

CURBSIDE RECYCLING (CR):

All containers must be empty, cleaned, and washed of contents.

MUNICIPAL SOLID WASTE (MSW), CURBSIDE RECYCLING (REC) & BULK ITEM COLLECTION (BIC)

When did the program begin? The program began on July 2, 2008. It will end on July 1, 2013.

A carry-out service is available to residents regarded as disabled under the Americans with Disabilities Act of 1990 whose dwelling unit does not have residing therein another individual capable of transporting MSW and recyclables to the designated location. Trash, recyclables and bulk items will be picked up at the door.

Holidays observed: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day. **Collection will be one day late when your collection day falls on or follows these holidays. EXCEPTION: There is NO CHANGE in service prior to or after a holiday that falls on a Saturday or Sunday**

MUNICIPAL SOLID WASTE (MSW):

Municipal Solid Waste (MSW), for purposes of this contract, shall include garbage (food waste), refuse (the useless or worthless part of something), grass clippings and leaf waste (any combination of leaves, brush, tree and shrub trimmings and vegetative materials from gardens).

AUTUMN LEAVES TRANSPORT SERVICE

The Autumn Leaves Transport Service is an outstanding service provided for residents of the Township who are at least age 60 or who are disabled. The 11 passenger van is available Monday through Friday from 8:00 a.m. to 4:00 p.m. to provide transportation to medical appointments, grocery stores, banks, meetings, etc. The van is available after hours for emergency situations. Calls for service should be made at least 48 hours in advance except in the event of an emergency. One-day recreational trips to Roots Market, etc. are also planned and generally are scheduled for Tuesdays.

The administrative office for the service is located in the East Hanover Township Municipal Building. The office is staffed by volunteers on Mondays, Wednesdays and Fridays from 9:00 a.m. to 12:00 noon. Appointments for services need to be made during these times.

Donations are accepted for all trips and services. East Hanover Township provides the office area, the telephone and the fuel for this service. The Dauphin County Area Agency on Aging provides the insurance for the services of the van. The van is owned by the Dauphin County Area on Aging and is housed in a Township garage. EAST HANOVER TOWNSHIP SENIOR CENTER

THE MANADA CONSERVANCY

The Manada Conservancy is a land trust, created in 1995 by residents of East Hanover Township and neighboring municipalities who are concerned about unplanned loss of land in our region to development. It is a private charitable organization. By working with individuals, private groups, and local, county and state agencies, the Conservancy seeks ways to protect a wildlife habitat and preserve open space. It also seeks ways to help farmers keep their land in agricultural use while maintaining its financial value.

Land trusts are becoming a widely used method for private and voluntary preservation of farmland and natural resources, with over forty such organizations in Pennsylvania alone. The Manada Conservancy is modeled after other larger or more distant conservancies but its focal point will be our own communities and the nearby areas with which we are most familiar.

Land trusts protect land by outright purchase and stewardship by working with government agencies, by purchasing or accepting donations of conservation easement and development rights, and by creatively working with property owners who want to preserve the natural resources on their land. The conservancy can accept land, easements, services and money as tax deductible donations.

The name “Manada Conservancy” was chosen to signify not only the geographical area upon which the Conservancy hopes to focus, but also the importance of waterways, habitat and the rich historical heritage of the region. The Manada Creek is near the center of the focal area and feeds into the Swatara Creek. Abundant wildlife can be found along these waterways as well as evidence of Native American settlements and other unique historical sites, such as the Union Canal.

The Board of Directors is composed of individuals representing East Hanover, West Hanover, South Hanover, Hummelstown and Derry Townships in Dauphin County and East Hanover Township in Lebanon County.
